Symeon C. Symeonides, Alex L. Parks Distinguished Chair in Law & Dean Emeritus

Symeon C. Symeonides was born and raised in Lythrodontas, Cyprus, and studied law in Greece, graduating with the highest grade in the history of the University of Thessaloniki Law School—a perfect 10. He also holds an LLM and an SJD from Harvard, and three honorary doctorates. He joined Willamette in 1999 as Dean of the College of Law and served in that capacity until 2011. Previously, he taught at the University of Thessaloniki (1976–78), and Louisiana State University (1978–99), where he was the Judge Albert Tate Professor of Law (1987) and vice chancellor (1991-97).

Symeonides has published 30 books and 135 articles, some of which appear in Chinese, French, German, Greek, Italian, or Spanish. His work has been cited by the supreme courts of the United States, the United Kingdom, and Israel (22 times). Reviewers of his work referred to him as "the conflicts giant", "the father of choice of law in the twenty-first century", and "the world's leading expert on US and comparative conflicts law". His last book has been characterized as "a worthy successor" of Joseph Story's classic Commentaries (1834) and "an asset for the discipline . . . worldwide". Reviewers of his previous books characterized them as "brilliant contributions to legal theory", "original", "masterful", "indispensable", "cogent", "penetrating" and "path breaking". His work has been honored with two Lifetime Achievement awards, five scholarly prizes, and the Aristeion of the Republic of Cyprus, the highest civilian honor in that country.

Symeonides has served as president of the International Association of Legal Science and the American Society of Comparative Law. He is a member of the Academy of Europe (*Academia Europaea*), titular member of the International Academy of Comparative Law and the *Institut de Droit International*, and life member of the *Groupe Européen de Droit International Privé* and the American Law Institute.

Symeonides record in law reform includes drafting the Louisiana codification on Conflict of Laws, the Oregon codification for tort conflicts, a draft Code of Private International Law for Puerto Rico, and an international model law on internet conflicts, which was unanimously adopted by the *Institut de Droit International*. He spent six months in Brussels, chairing five working groups drafting new laws for the European Union, and later participated in drafting and negotiating two international convention under the auspices of The Hague Conference on Private International Law. He also provided legislative advice to the EU Parliament and several foreign governments. He currently serves as an Adviser for the Third Restatement on Conflict of Laws.
